



## LIMITED LIFETIME WARRANTY

Korky's Outpost LLC, dba Lifestyle Docks, provides a limited lifetime warranty for aluminum dock components to the original purchaser only when purchased from Korky's Outpost LLC. Lifestyle Docks are not warranted in conjunction with other products not manufactured by Korky's Outpost LLC.

**INTENDED USE:** Lifestyle aluminum frame docks are intended to be used as marine boat docks or piers for residential applications only and are not intended for any other use. The limited lifetime warranty is valid only when used for the intended application. Purchasers should fully inspect all components before assembling or installing.

**WARRANTY: Providing that the Lifestyle Dock is assembled and installed as per the instructions supplied, Korky's Outpost LLC warrants that all aluminum components will be free of defects in material and/or workmanship under normal use, service and maintenance for the life of the product. This warranty includes broken welds, deformed components, material defects, and manufacturing or workmanship defects. Repairs or replacement will be provided through Korky's Outpost LLC. Replacement may consist of providing replacement parts or frame components (see below). This warranty does not include installation or re-assembly of frame components. Warranty does not apply to plastic wheels, decking, steel components, bolts or fasteners. Refer to manufacturer's warranties for these items.**

**TERM:** Korky's Outpost LLC provides a full repair or replacement warranty for the life of the product. Korky's Outpost LLC may repair, replace or provide a full or partial refund at its sole discretion according to the following terms. The claimant must notify Korky's Outpost LLC in writing within 10 days of discovering the defect. Such notice must include presentation of the defective part or photos of the defective component to be presented to the authorized dealer from which the product was originally purchased along with the original purchase invoice or receipt. If Korky's Outpost LLC certifies that the items are indeed defective, Korky's Outpost LLC will repair, replace or provide a full or partial refund in accordance with this warranty.

**WARRANTY LIMITATIONS:** The successful performance of Lifestyle aluminum dock frame components is dependant upon many factors beyond our control. Therefore, except for such repair, replacement or refund outlined above, Korky's Outpost LLC:

1. MAKES NO WARRANTY OR GUARANTEE, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF FITNESS, and DESIGN CAPABILITY OR MERCHANTABILITY RESPECTING ITS PRODUCTS.
2. Under no circumstances shall Korky's Outpost LLC be liable for any special, incidental or consequential damages including but not limited to: personal injury, property damage, damage to or loss of product, loss of profits or revenue. The price stated for the products is a consideration in limiting Korky's Outpost LLC's liability and buyers remedy.
3. This limited lifetime warranty shall not apply to any product subject to misuse due to common negligence or accident nor to any product made by the seller not used in accordance with the printed instructions or specifications of Korky's Outpost LLC or that have been used beyond the represented and rated capacity of the product. This warranty does not apply to corrosion from salt water applications, damage from owner misuse, improper assembly, improper installation, overloading, negligence, accident, damage by ice and severe weather conditions or seasonal installation or removal by mechanical means (cranes, lifts, tractors, vehicles, etc.). Warranty is void if the aluminum components have been altered or modified by the user.
4. This limited lifetime warranty is applicable only to those parties heretofore mentioned, and is not assignable, transferable nor will it insure to the benefit of any sub-purchaser of the original equipment manufacturer other than the original retail purchaser.
5. Application may be subject to local building codes and is the responsibility of the purchaser to adhere to.
6. As stated above, Korky's Outpost LLC reserves the right to inspect all components claimed to be defective or damaged under the terms of the warranty.
7. Korky's Outpost LLC limits of warranty is defective material replaced, repaired, refund or credit against further purchases. All information and data provided at time of writing is believed to be accurate and complete, however, are provided without any guarantee or responsibility of any kind, expressed or implied. Suggestions or statements concerning possible use of products are made without representation that any such use is free from patent infringement and are not recommendations to infringe any patent.
